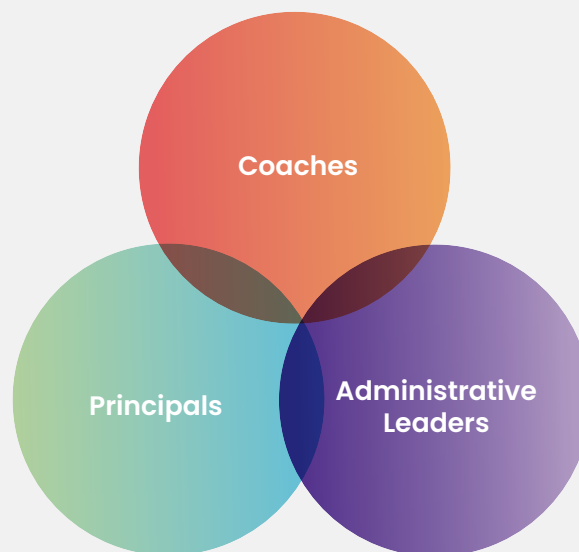

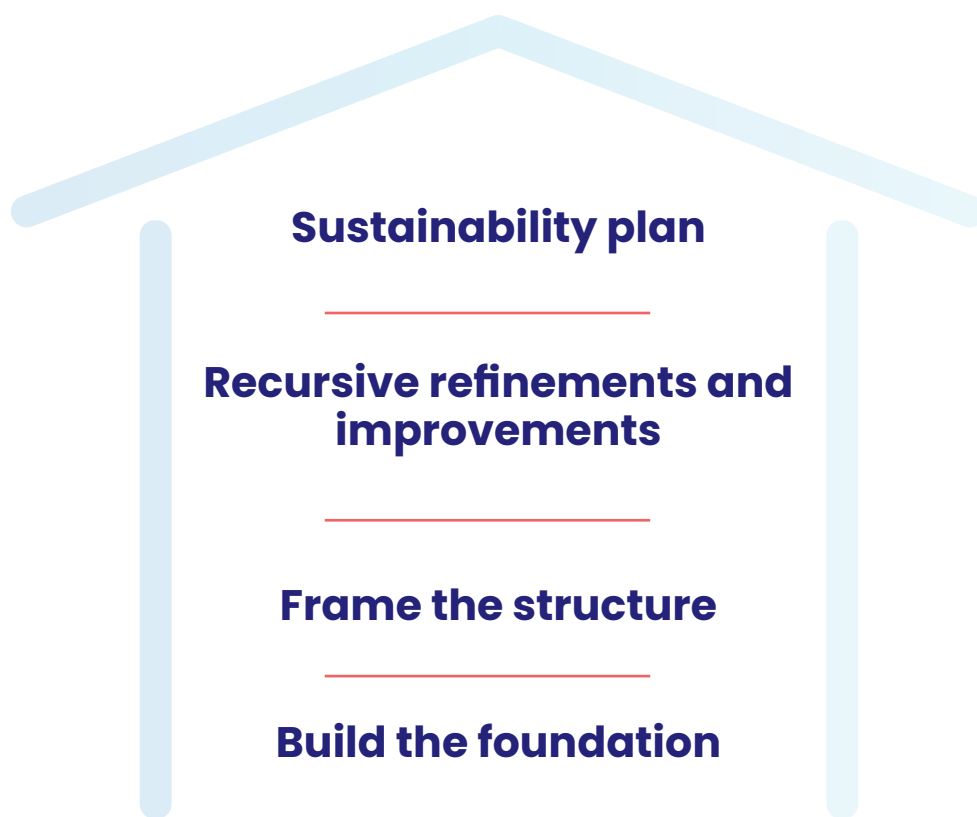

The Four Stages for a Successful Implementation

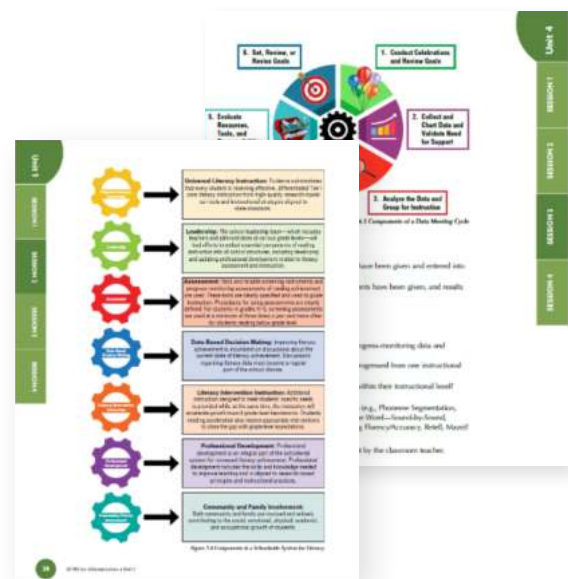
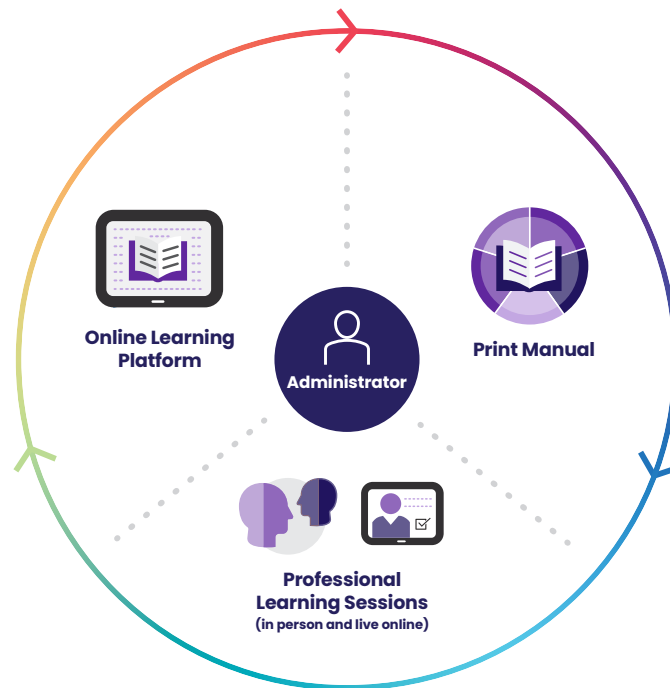
