



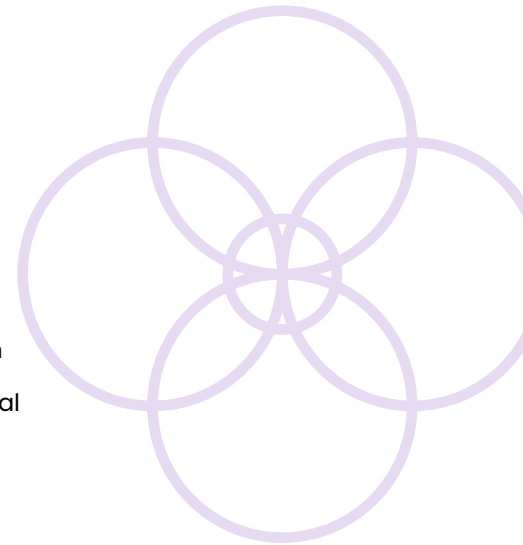

- Lexia Lessons used daily for 30 minutes during DELD instruction
- Students use Lexia English online at home 45-60 minutes weekly

### Lexia Lessons

(used by classroom teachers)

- Whole-class listening and speaking; Lexia Lessons Monday through Thursday
- Whole-class Lexia Skill Builders to facilitate peer-to-peer conversations on Fridays

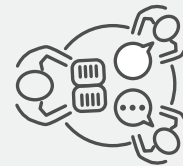
